




LOCATION

The property is situated in a secondary trading position in Stafford town centre on the North side of Salter Street between its junctions with Vine Street and Malt Mill Lane. The Central Retail Park is close by with an Aldi supermarket, B&M discount store and a McDonalds drive-thru restaurant represented together with the benefit of free car parking limited to two hours. Salter Street is dominated by a mixture of niche retailers with estate agents, hair salons, barbers, beauty salons, a convenience store, cafés, bars represented and with the Vine Hotel close by.

DESCRIPTION

The premises form part of a two-storey brick and tile development of shops with apartments above and provide a sales area on the ground floor with a timber and glazed shop front.

The unit has most recently been used as a bubble tea shop but would be suitable for a wide variety of alternative retail or non-retail purposes subject to any planning consent considered appropriate by the relevant local authority.

SERVICES

Mains water, electricity and drainage are connected.

ASSESSMENTS

The local authority for rating purposes is Stafford Borough Council. The rateable value of the property has been assessed at £10,750 with no uniform business rates payable subject to certain tenant qualifying criteria. These details have been based on the information provided by the Valuation Office's website and should be double-checked by any party intending to enter any commitment that relies on their accuracy.

EPC

The Energy Performance Certificate for this property indicates a rating of 51 within Band C. A full certificate with recommendations will be provided on request.

TERMS

The premises are available on new full repairing lease for a term to be agreed at a rental of £9,950 per annum with upward only rent reviews to be at three yearly intervals. The landlord will insure the unit and then recharge the tenant the appropriate apportioned cost thereof. A service charge will also apply. VAT is applicable on the rental and service charge.

LEGAL COSTS

Both parties are to be responsible for their own legal costs incurred in the preparation of the lease and the counterpart lease, together with any Stamp Duty and VAT due thereon.
